(excluding instruction protocol and introduction)

- Text given in normal font should be read out by the interviewer.
- Most answers do not have to be read out, unless explicitly indicated.
- Text preceded by INT are instructions for the interviewer.
- **Text in bold are technical programming instructions.**
- → **question BA103A** means go to the question specified.
- Many questions are preceded by **conditions in bold** or have **conditions in bold** in the answers. They do not appear in the text the interviewer/respondent sees..
- Questions in the second wave begin with a **B**, questions from the first wave begin with an **A**.
- **NKPS respondents** are main sample respondents. **SPVA respondents** are migrant sample respondents. In wave 1, separate questionnaires were developed for the two groups. In wave 2, extra questions were put to SPVA-respondents to resolve discrepancies between the two groups.
- The interviewer is often referred to **Module X**. The questions referred to are standard questions about the family member (**Alter**). The set of questions differs per Alter, however. Where the reference is given, the questions concerned are usually specified, but the conditions are also given in the Module X itself.
- Text in brackets: **{text}** is information that needs to be retrieved from earlier sources of information (either from this (=second) wave or the first wave).
- Gold is for CAPI and CATI, green for CAPI, blue for CATI and red for CAWI

A. BACKGROUND

When fixing a date for the interview (by phone or in person), the interviewer will screen who should be interviewed and whether this person is willing to take part. As a doublecheck, the questions below will be answered at the beginning of the interview to make should that the right person is being interviewed.

We would first like to check your name and address. We received this information during our earlier interview.

We will start by asking for some background information.

If necessary, repeat for potential respondent $X = 1$ to $N = 20$

BA101_X INT: Enter the respondent's sex/your sex is: (if this is not clear: What is your sex?)/ What is your sex?

- 1 male
- 2 female

BA102_X What is your date of birth?

- Enter the date of birth [dd-mm-yyyy]

If BA101 and BA102 do not tally with the information gathered in wave 1 (AA101 and AA102), ask questions BA103 to BA103B:

NKPS respondents always know when the interview took place; this is not always the case for SPVA respondents. The month is missing in 70 cases – if this is the case, leave out month in 'month/year'. The year is missing in 7 cases – if this is the case, replace 'in month/year' by 'in our last interview'.

INT: the last interview for SPVA respondents took place in 2002 or 2003.

BA103_X It is very important that we interview the same person we interviewed in {month/year interview wave 1}.

Based on our information, we then interviewed a {AA101} born on {AA102} who is a member of your household. Is that someone else in your household?

BA103A_X The information we gathered at the time may be wrong. Were you the person interviewed last time?

Now calculate BAGE: respondent's age in years based on date of interview and date of birth (BA102_X)

B. PARENTAL HOME

The next questions are about your parental home

If AB203 = 4 (both parents of father not alive wave 1): do not ask BB203 to BB207 but go on to question BB303. If you do not know whether or not the parents are alive, ask the question anyway.

BB203 Are the parents of your own (biological) father still alive?

- 3 only (grand)mother → **question BB206**
- 4 neither alive → **question BB303**

BB204 How often have you seen your grandfather on your father's side in the past 12 months?

Only ask questions B206 and B207 if the grandmother on the respondent's father's side is still alive.

Only ask questions B206 and B207 if the grandmother on the respondent's mother's side is still alive (BB303=1 of BB303=3)

Only ask BB400FA if the respondent is an NKPS respondent; for SPVA respondents go to BB400FB.

BB400FA. Based on our information your own father was

INT: Read out loud:

- not alive (**AX401F=2**)
- married to or living with your mother (**AX401F=1 and AX401M=1 and AB401=2**)
- living alone (**AX401F=1 and (AB403=2 or AB405=1)**)
- married to or living with a new partner (**AX401F=1 and AB405=2 or AB404=1**)

At the time of the last interview in {month/year interview wave 1} {information obtained during last wave will now appear on the screen}.

If you do not know whether the father was alive during wave 1 skip questions about father and continue with mother: BB400MA.

Is this correct?

- 1 yes → question BB401FA, BB400FA is entered in BB401FA
- 2 no

If information is missing, ask BB400FB.

NKPS respondents always know when the interview took place; this is not always the case for SPVA respondents. The month is missing in 70 cases – if this is the case, leave out month in 'month/year'. The year is missing in 7 cases – if this is the case, leave out 'in {month/year interview wave 1}'.

INT: the last interview for SPVA respondents took place in 2002 or 2003.

- BB400FB** What was your own father's situation at the time of the last interview, in {month/year interview wave 1}?
INT: Read out the answers.
- 1 father not alive
 - 2 father married to or living with your mother
 - 3 father living alone
 - 4 father married to or living with a new partner

**[save result of BB400FA-BB400FB in question BB401FA evaluate and choose the appropriate routing
Do NOT show information on screen (again)]**

- BB401FA** At the time of the last interview the situation of respondent's own father was
- 1 father not alive → **question BB400MA (no Module X questions)**
 - 2 father married to or living with your mother
 - 3 father living alone
 - 4 father married to or living with a new partner

- BB401FB** Is your father still alive?
- 1 yes → **skip next question (Module X questions)**
 - 2 no

- BB401FC** In which year did he die?
If the respondent does not know the year of death, ask for the best possible estimate.
- enter year → **question BB400MA (no Module X questions)**

Questions about own father: If BB401FB = 1, ask questions BX501, BX601, BX602, BX603, BX604, BX604A, BX701 to BX705, see Module X

Only ask BB400MA if the respondent is an NKPS respondent; for SPVA respondents go to BB400MB.

If you do not know whether the mother was alive during wave 1 skip questions about mother and continue with father (voor zover nog wel bekend); otherwise go to BB600.

- BB400MA** Based on our information your own mother was:
INT: Read one of the options that will appear on the screen
- not alive (**AX401M=2**)
 - married to or living with your father (**AX401M=1 and AX401F=1 and AB401=2**)
 - living alone (**AX401M=1 and (AB407=2 or AB409=1)**)
 - married to or living with a new partner (**AX401M=1 and AB409=2 or AB408=1**)
at the time of the last interview, in {month/year interview wave 1} {information obtained during last wave will now appear on the screen}.
- Is this correct?
- 1 yes → **question BB401MA**
 - 2 no

If information is missing, ask BB400MB.

**NKPS respondents always know when the interview took place; this is not always the case for SPVA respondents. The month is missing in 70 cases – if this is the case, leave out 'month' in 'month/year'. The year is missing in 7 cases – if this is the case, leave out 'in {month/year interview wave 1}'.
INT: the last interview for SPVA respondents took place in 2002 or 2003.**

- BB400MB** What was your own mother's situation at the time of the last interview in {month/year interview wave 1}?
INT: read out the answers.
- 1 mother not alive
 - 2 mother married to or living with your father
 - 3 mother living alone
 - 4 mother married to or living with a new partner

**[save result of BB400MA-BB400MB in question BB401MA evaluate and choose the appropriate routing
Do NOT show information on screen (again)]**

- BB401MA** At the time of the last interview the situation of respondent's own mother was
- 1 mother not alive → **question BB404F (if relevant, otherwise go to BB405F etc)**
 - 2 mother married to or living with your father
 - 3 mother living alone
 - 4 mother married to or living with a new partner

- BB401MB** Is your mother still alive?
- 1 yes → **skip next question**
 - 2 no

BB401MC In which year did she die?
If the respondent does not know the year of death, ask for the best possible estimate.
– enter year → go to question **BB600**

Questions about own mother: If BB401MB = 1, ask questions BX501, BX601, BX602, BX603, BX604, BNX604A, BX701 to BX705, see Module X

Based on the situation in wave 1, and whether or not the parents are still alive in wave 2, a division is now made between the following conditions:

- parents together in wave 1
- parents no longer together in wave 1 and:
 - father - single
 - with new partner
 - mother - single
 - with new partner

If one parent has died since wave 1 (BB400FB=1 for father, BB400MB=1 for mother), no questions will be asked about this parent's marital history since wave 1.

IF THE PARENTS WERE TOGETHER IN WAVE 1

Ask the following three questions if the parents were together in wave 1 (BB401FA=2 and BB401MA=2) and both parents are still alive now: BB401FB = 1 and BB401MB = 1.

BB402 Did your parents divorce since the last interview?
1 yes
2 no → question **BB600**

BB403F Is your father now married to or living with a new partner?
1 yes
2 no → question **BB403M**

At this point, a number of questions contained in Module X are asked about standard characteristics of the father's current partner, namely questions BX201, BX301, BX501, BX603, BX604. Then continue with question BB403M.

BB403M Is your mother now married to or living with a new partner?
1 yes
2 no → question **BB600**

At this point, a number of questions contained in Module X are asked about standard characteristics of the mother's current partner, namely questions BX201, BX301, BX501, BX603, BX604. See Module X for details. Then continue with question BB600.

IF FATHER WAS SINGLE IN WAVE 1

Ask the following question if BB401FA = 3 and BB401FB = 1 (father was single in wave 1).

BB404F Is your father now married to or living with a new partner?
1 yes
2 no → question **BB404M**

At this point, a number of questions contained in Module X are asked about standard characteristics of the father's current partner, namely questions BX201, BX301, BX501, BX603, BX604. See Module X for details. Then continue with question BB404M.

IF MOTHER WAS SINGLE IN WAVE 1

Ask the following question if BB401MA = 3 and BB401MB = 1 (mother was single in wave 1).

BB404M Is your mother now married to or living with a new partner?
1 yes
2 no → question **BB405F**

At this point, a number of questions contained in Module X are asked about standard characteristics of the mother's current partner, namely questions BX201, BX301, BX501, BX603, BX604. See Module X for details. Then continue with question BB405F.

IF FATHER HAD NEW PARTNER IN WAVE 1

Ask the following two questions if BB401FA = 4 and BB401FB = 1 (father had new partner in wave 1).

BB405F Is your father still married to, or does he still live with this partner?

- 1 yes, still together → **question BB405M**
- 2 no, divorced or split up
- 3 no, partner has died

BB406F Is your father now married to or living with a partner?

- 1 yes
- 2 no → **question BB405M**

At this point, a number of questions contained in Module X are asked about standard characteristics of the father's current partner, namely questions BX201, BX301, BX501, BX603, BX604. See Module X for details. Then continue with question BB405M.

IF MOTHER HAD NEW PARTNER IN WAVE 1

Ask the following two questions if BB401MA = 4 and BB401MB = 1 (mother had new partner in wave 1)

BB405M Is your mother still married to, or does she still live with this partner?

- 1 yes, still together → **question BB600**
- 2 no, divorced or split up
- 3 no, partner has died

BB406M Is your mother now married to or living with a partner?

- 1 yes
- 2 no → **question BB600**

At this point, a number of questions contained in Module X are asked about standard characteristics of the father's current partner, namely questions BX201, BX301, BX501, BX603, BX604. See Module X for details. Then continue with question BB600.

BB600 In which country did you live shortly after you were born?

- code the place of residence with the aid of the Country Lookup

If BB600 = Netherlands

BB601 In which city did you live shortly after you were born?

- INT: Use the official spelling; e.g. 's-Gravenhage instead of Den Haag.*
- code the place of residence with the aid of the City Lookup

BB602 In which year did you leave the parental home to start living on your own for the first time?

- 0 Has never lived on his/her own
- enter the year

Questions BB603 and BB604 are only asked if the respondent lives with at least one of his or her parents; i.e. BX501 = 1 for father and/or mother (BX501F=1 and/or BX501M=1).

BB603 Your parent(s) also live(s) in this house. Are you living in your parental home or are your parents/is your parent living in with you?

- 1 respondent living in parental home
- 2 parent(s) living in respondent's home → **question BB616**

BB604 Within how many years are you planning to leave the parental home and start living on your own?

- INT: If the respondent is/you are not planning to live on his/her/your own, enter '99'.
If the question is not applicable, enter '88'.*

- enter the number of years

If BB602 = 0, go to question BC003.

BB616 In which country did you live immediately after you left the parental home to start living on your own for the first time?

- code the place of residence with the aid of the Country Lookup.

If BB616 = Netherlands

BB616B In which city did you live immediately after you left the parental home to start living on your own for the first time?

INT: Use the official spelling; e.g. 's-Gravenhage instead of Den Haag.

– code the place of residence with the aid of the City LookUp

BB617 Have you lived independently of your parents/carers ever since or did you ever go back and live in the parental home for a consecutive period of six months or more?

1 yes, lived independently ever since → **question BC003**

2 no, has gone back to live with parents/carers

BB618 In which year did you last leave the parental home to start living on your own?

0 Has never lived on his/her own

– enter the year

C. PARTNERS, PARENTS-IN-LAW AND CHILDREN

MODULE STRUCTURE

- Questions about the relationship the respondent was in at the time of the last interview
 - relationship history
 - birth of new children
 - if divorced: characteristics of divorce
- Questions about relationships entered into after the last wave
 - if relationship has ended before this interview – limited number of questions
 - if respondent is still in this relationship – large number of questions
 - characteristics of new partner
 - relationship history
 - birth new children with new partner
 - characteristics of new parents-in-law (not for partner not sharing household with respondent, a so-called Living-Apart-Together, or LAT partner)
- Questions about children who had already been born last time.
- Questions about births of new children
- Questions about the ex-partner who was already an ex-partner last time.

Note that the characteristics of the children mentioned in Module X should not be dealt with until the parents' relationship history has been recorded. This is important because information is needed about the possible divorce of the parents in Module X (there will be additional questions about children of divorced parents).

Based on information obtained in wave 1 the following information will be read out/will appear on the screen

- BC003** At the time of the last interview, in {month/year interview wave 1}
- 1 you did not have a partner (**AC101=2**)
 - 2 you had a partner with whom you did not live (**AC104=2**)
 - 3 you had a partner with whom you lived outside of marriage (**AC104=1 en amarstat = 0 of 2 of 3**)
 - 4 you were married and lived with your spouse (**AC104=1 en amarstat=1**)

- BC004** Is this correct?
- 1 yes → **question BC006**
 - 2 no → **question BC005**

- BC005** What was your situation at the time?

For NKPS respondents with missing status (n=2) and for SPVA respondents the question is adjusted. NKPS respondents always know when the interview took place; this is not always the case for SPVA respondents. The month is missing in 70 cases – if this is the case, leave out month in 'month/year'. The year is missing in 7 cases – if this is the case, leave out 'in {month/year interview wave 1}'

INT: The last interview for SPVA respondents took place in 2002 or 2003.

- BC005** What was your situation at the time of the last interview in {month/year interview wave 1} ?

INT: Read out:

- 1 you did not have a partner
- 2 you had a partner with whom you did not live
- 3 you had a partner with whom you lived outside of marriage
- 4 you were married and lived with your spouse

- BC006**
- 1 respondent did not have a partner → **question BC027_1**
 - 2 respondent had a partner with whom he/she did not live
*Int: The next questions are about the partner you had at the time of the interview in {month/year interview wave 1} → **question BC007***
 - 3 respondent had a partner with whom he/she lived outside of marriage
*INT: The next questions are about the partner you had at the time of the interview in {month/year interview wave 1} → **question BC010***
 - 4 respondent was married and lived with his/her spouse
*INT: The next questions are about the partner you had at the time of the interview in {month/year interview wave 1} → **question BC014***

QUESTIONS ABOUT PARTNER RELATIONSHIPS THAT EXISTED IN WAVE 1

If respondent had a partner in wave 1, but this was not recorded, correct this by asking questions BC006A to BC006D.

BC006A In which year was this partner born?
.... enter year of birth

BC006B In which country was this partner born?
– Code the country with the aid of the Country LookUp.

BC006C In which country did this partner live before you started a relationship with him/her?
– Code the country with the aid of the Country LookUp.

BC006D What sex is this partner?
1 male
2 female

BC007 Did you start living with this partner after the interview? (also count living with spouse)
1 yes → **question BC009**
2 no → **question BC008**

BC008 **At this point, a number of questions contained in Module X are asked about the standard characteristics of the LAT partner, namely questions BX601, BX602, BX603, BX604. Then continue with question BC012 (marriage). Note that BX603 and BX604 assume that the LAT partner is still alive. If the LAT partner has died in the meantime (this is asked further on) questions BX603 and BX604 may be painful.**

BC009 In which month and which year did you start living with this partner?
.... month year

BC010 and BC011 are asked before BC012 so that short-lived prenuptial agreements are also recorded.

BC010 Have you and your partner concluded a cohabitation agreement?
1 yes
2 no

BC011. Have you and your partner entered into a registered partnership?
1 yes
2 no

BC012 Did you marry this partner since the last interview?
1 yes
2 no → **question BC015**

BC013 In which month and which year did you marry this partner?
.... month year

BC014 Did you marry with a prenuptial agreement?
1 yes
2 no

BC015 Are you and this partner still together?
INT: In the case of relationships where partners do not share a household (so-called LAT relationships) we would like to know whether the respondent is still in a relationship with this partner. Death of partner also counts as a 'no.'
1 yes, still together → **question BC018A or BC018B after having carried out the instruction below relating to BPARTNER**
2 no, no longer together

The variable BPARTNER (current partner status) is now prompted and partially filled with the values:

- 1 **LAT partner: (BC007 = 2 and BC015 = 1)**
- 2 **Living together outside of marriage: (BC006 = 3 and BC012 = 2 and BC015 = 1) or (BC007 = 1 and BC012 = 2 and BC015 = 1)**
- 3 **Married: ((BC006 = 4 or BC012 = 1) and BC015 = 1)**

BPARTNER is filled further on with information about new partners

- BC016** How did this relationship end?
1 split up/divorced → **question BC017A**
2 partner died → **question BC017C**

BC017A In which month and which year did you split up/did your relationship end?
.... month year

Only ask BC017B if (BC006=4 or BC012=1) and BC015=2

- BC017B** Are you officially divorced?
1 yes
2 no → **question BC019**

BC017C In which month and which year did your partner die?
.... month year
→ **question BC019**

Question BC018A only applies to men who are married to a woman. (BA101=1, BPARTNER=3, AC121=2)
If this information is missing for NKPS respondents (n=2) skip questions BC018A and BC0018B.
If this information is missing for SPVA respondents, assume the partner is the opposite sex to the respondent; i.e. if respondent is a man, partner is always a woman, and vice versa.

- BC018A** Does your partner use her own name or yours?
1 (usually) her own name
2 (usually) my name
3 both names at the same time
4 sometimes one name, sometimes the other

Question BC018B only applies to women who are married to a man (BA101=2, BPARTNER=3, AC121=1)
If this information is missing for SPVA respondents, assume the partner is the opposite sex to the respondent; i.e. if respondent is a man, partner is always a woman, and vice versa.

- BC018B** Do you usually use your own name or your husband's name?
1 (usually) my own name
2 (usually) my husband's name
3 both names at the same time
4 sometimes one name, sometimes the other

BC019 does not apply to female respondents aged 46 or over and to male respondents with a female partner aged 46 or over (AC102≥46).

BC019 Have you and your partner {replace 'your partner' by 'this ex-partner' if BC016 = 1} had a child together since the last interview?
1 yes
2 no → **question BC021**

BC019B How many children have you and your partner {replace 'your partner' by 'this ex-partner' if BC016 = 1} had since the last interview?
– enter the number of children

BC020K We would like to ask a few questions about this child {replace 'this child' by 'each of these children' if BC019B >1}.

BC020_XX What is the first name of this child?

At this point, a number of questions contained in Module X are asked about standard characteristics of the new own children, namely:
(Note that Module X (incl. names of variables) does make a distinction between own children and adoptive children, but makes no further distinction in the names of variables within these categories)
If split up (BC016 = 1): BX201, BX301, BX401, BX402, BX501B to BX501I, BX502, BX602, BX603, BX604, BX605, BX606, BX701 to BX705.
If partner died (BC016 = 2): BX201, BX301, BX401, BX402, BX501, BX502, BX602, BX603, BX604, BX701 to BX705.
If still together (BC015 = 1, so BC016 is missing): BX201, BX301, BX401, BX402, BX451 to BX453, BX501, BX502, BX602, BX603, BX604, BX701 to BX705.

BC021 not for female respondents aged 46 or over and for male respondents with a female partner aged 46 or over (AC102≥46).

- BC021** Have you and your partner {replace 'your partner' by 'this ex-partner' if BC016= 1} adopted any children since the last interview?
 1 yes
 2 no → **question BC023**
- BC021B** How many children did the two of you adopt since the last interview?
 – enter the number of children
- BC022K** We would like to ask a few questions about this child {replace 'this child' by 'each of these children' if BC021B >1}.
- BC022_XX** What is the first name of this child?

At this point, a number of questions contained in Module X are asked about standard characteristics of the new adoptive child/children, namely:

If split up (BC016 = 1): BX201, BX301, BX401, BX402, BX501B to BX501I, BX502, BX602, BX603, BX604, BX605, BX606, BX701 to BX705.

If partner died (BC016 = 2): BX201, BX301, BX401, BX402, BX501, BX502, BX602, BX603, BX604, BX701 to BX705. If still together (BC015 = 1, so BC016 is missing): BX201, BX301, BX401, BX402, BX451 to BX453, BX501, BX502, BX602, BX603, BX604, BX701 to BX705.

- BC023** Is your father-in-law {replace 'your father-in-law' by 'this ex-partner's father' if BC016 = 1 in which case leave out explanation after question mark} still alive? (we are referring to your partner's father)
 1 yes
 2 no → **question BC024**
 3 don't know → **question BC024**

If BC015=1, a number of questions contained in Module X are asked about standard characteristics of the father-in-law, namely questions BX501, BX601, BX602, BX603, BX604.

If BC015=2, a number of questions contained in Module X are asked about standard characteristics of this ex-partner's father, namely questions BX601, BX602, BX603, BX604 (not BX501!!) Note wording 'this ex-partner's father'.
