5th GGP User Conference 23 - 25 October 2019 Paris, France

Call for Abstracts



The Generations & Gender Programme, in cooperation with INED, is delighted to announce the **5th GGP Conference** to be held 23-25 October 2019 in Paris. This international conference aims at bringing together researchers working with data from the Generations and Gender Survey (GGS) and invites them to present and discuss their most recent methodological approaches and empirical findings.

The conference provides a forum for exchange of ideas among current as well as prospective GGP users, policy makers and the research community at large. Abstracts of papers focusing on – but not limited to – the following topics are welcome:

- Demographic behaviours of subpopulations and different social groups
- Social mobility and inequalities
- Division of paid and unpaid work
- Cohabitation, union formation and dissolution
- Subjective well-being and demographic outcomes
- Labour market and economic well-being
- Fertility intentions and their realization
- Data quality and validation, methodological considerations in studying demographic behaviour
- Intergenerational links and transfers
- Survey methods and implementation

Papers using data sources that compliment or are similar to those in the GGS, including (but not limited to) the Demographic and Health Surveys (DHS), the Family and Fertility Survey (FFS), and the Human Fertility Database (HFD) are also invited as are papers combining the Gender and Generations Survey with other sources of data.

Papers can be submitted for oral or poster presentation and there will be a prize for the best poster. There is no fee for the conference but places are limited. Abstracts should be submitted via the form on the GGP's website www.ggp-i.org by 26th April 2019. Authors will be notified in mid-June about the outcome of their submission.









The GGP in SSHOC



On March 11 & 12 the GGP joined 19 other partner organisations for the kick off meeting of the Social Science and Humanities Open Science Cloud (SSHOC) project in Utrecht, The Netherlands.

This €14.5 million project (H2020-INFRAEOSC-04-2018, grant agreement 823782) will realise the social sciences and humanities (SSH) part of the **European Open Science Cloud (EOSC)** by offering a scalable and flexible access to research data and related services adapted to the needs of the SSH community.

SSHOC will maximize re-use of services and data through the application of Open Science practices and apply the **FAIR** (Findable, Accessible,

Interoperable and Reusable) Data Principles to the management of data to increase the efficiency and ease in creating and re-using them.

In SSHOC, the GGP collaborates with the European Linguistics Infrastructure (CLARIN) and the European Value Study (EVS) to develop new approaches to harvesting linguistic data from survey interviews.

Inclusion in the Estonian National Research Infrastructure Roadmap
