Harmonized Histories Data - The Netherlands



A new data source which has been added to the **Harmonized Histories** dataset is now available:

- Country: The Netherlands
- Year of data collection: 2013
- N=10,255 (5,075 women, 5,180 men)

The Harmonized Histories is an international comparative dataset, which focuses on **fertility and partnership histories**, created through harmonizing data from existing surveys into one common format dataset. In addition, this dataset captures information on the socio-economic status, place of residence, the childhood family, and so on. GGP Pilot in Buenos Aires



As part of the GGP's expansion, we are happy to announce the new pilot of the GGP to be conducted later this year in Buenos Aires, Latin America. This will be the first time that the new centralized survey has been deployed in this part of the world. This means that the new questionnaire has now been translated into Spanish and it is already generating considerable interest across the region. The hope is that many more Latin American countries will be joining the new round of data collection, enabling comparative research between various regions of the world that are experiencing low fertility.
