### ***GGP User Conference: Program***

We are pleased to announce that a provisional program for the 6th GGP User Conference is now available!

The conference, which takes place on **4-8 October 2021**, brings together researchers working with data from the GGS, the Contextual Database, and the Harmonized Histories, providing them a platform to discuss their most recent methodological approaches and empirical findings. Given the Covid-19 pandemic, this year's conference will be held online.

The scientific committee has now reviewed all submitted abstracts and a provisional program has been created. To facilitate a productive online conference, **daily sessions** will be held from 13h00 to 14h00 (Amsterdam

time). Moreover, an additional session with **flash talks** is scheduled (on October 5, 14h30-15h45).
