Zoom Instructions

The 6th GGP User Conference is hosted on Zoom. If you are not familiar with this platform, please carefully read the instructions below.

General

The zoom links to join the online conference can be found in this program, as well as the booklet of abstracts. To enter a session, you can either copy the link to your internet browser or open Zoom (if installed) and enter the Meeting ID and password provided.

By default, your microphone should be muted. We would appreciate it if you switch on your video when joining a session. The corresponding icons for audio and video are at the bottom of your screen. You can go to <https://zoom.us/test> to test your audio and camera settings.

Attendees

Make sure your microphone is turned off during the session. Leave your video on, if possible. This way, the presenters can more easily communicate with their audience.

The chair of the session will offer the opportunity for discussion after each presentation. If you would like to ask a question during the Q&A, please indicate so with the “raise hand” option or via the chat box. When the chair invites you to ask your question, please unmute your microphone using the corresponding icon at the bottom of the screen (or via the shortcut Alt-A).

Presenters

Join the virtual room of your session about 10 minutes prior to the official start. This way you can check sharing your presentation and check audio with the chair and host.

To share your slides with the audience during the presentation, use the “share screen” option. Make sure your microphone and video are switched on and that your slides are in presentation mode.

Chairs

Join the virtual session room about 10 minutes prior to the official start. This way you can check screen sharing and audio settings with the presenters and host.

Start the session with a welcome a few minutes after the official starting time. Remind people to turn off their microphone and turn on their video.

Keep an eye on time. In the general sessions, each speaker has been instructed to give a presentation of 10 minutes + 5 minutes of Q&A. In the flash session, the speakers have been instructed to give a presentation of 5 minutes, with room for general discussion after all presentations have finished.
