### *Visitors to the GGP Hub at NIDI*



The GGP Central Hub at NIDI was pleased to welcome **Dr. Andreas Haupt** (Karlsruhe Institute of Technology) and **Dr. Dafna Gelgiser** (Tel Aviv University) for a short research visit at the start of 2023. This visit was made possible by the COORDINATE Transnational Access Visits (TAV) programme.

At NIDI Haupt and Gelgiser presented their new research project on '**The Gendered Division of Cognitive Household Labor, Mental Load, and Family-Work Conflict in European Countries**'. Here's an excerpt from a [blogpost](#) they wrote on their visit:

"The main goal of our visit was to learn from the GGP team about existing and planned measures for the division of household labor, including cognitive labor. ## *Updates from the GGP HUB*



**The Generations & Gender Contextual Database (CDB) has been updated** thanks to the efforts of **Meredith Winn Lombard** (French Institute for Demographic Studies, INED). The CDB offers open access to comparable, aggregated contextual data for a large number of European, American and Asian countries, which can be also linked to the individual level data of the GGS. In addition to indicators regarding demography, the economy, gender, welfare and education, new indicators from the Oxford Covid-19 government response Tracker were added. Next to the updated and new indicators, we continue to provide access to The Generations & Gender Contextual Database Archive, which includes indicators that are no longer updated, and to the Multilinks Database on Intergenerational Policy Indicators. All the data can be browsed and downloaded from [the CDB online platform](#) maintained at INED. It is possible to create tabulations, graphs and save the data in different formats including API queries.

**Hong Kong has started fieldwork** since 16 February. In total, 16,000 invitation letters have been sent out with a combination of unconditional and conditional incentives (supermarket voucher). So far, there are 2,685 completed web interviews (2,488 in Chinese and 197 in English) and the response rate is around 17%. The first set of reminders has been sent out on the 1<sup>st</sup> of March. Meanwhile, fieldwork in Austria, the Netherlands and the UK is still ongoing.
