GGG in Croatia: Watch it now!



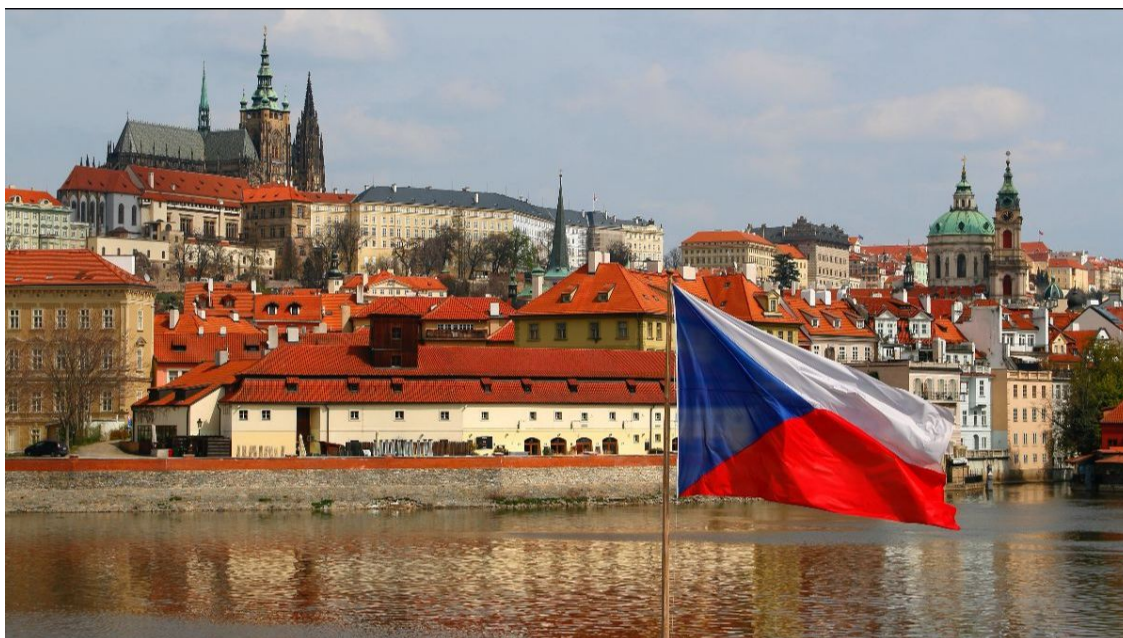
The twentieth webinar of the GGP-Connect seminar series, which was held on the 6th of June at 13:00 (CEST), hosted speakers from the **Croatian** national team.

In their talk **Ivan Čipin** and **Petra Međimurec** spoke about 'Croatia's experience with the GGS: Survey implementation, current progress and very preliminary findings'.

Fieldwork in Croatia started in May 2023 and is ongoing. After a successful pilot in 2018, the national team opted for a Push to Web (P2W) design and used the register of permanent and temporary residence from the Ministry of Interior as the sampling frame. **All 18000 invited survey participants were offered an unconditional cash incentive of 50 HRK.** So far the Croatia team received 4813 completed interviews.

Preliminary results show that roughly 15 percent of Croatians completing the interview are intending to move within Croatia in the next three years. Would you like to know more initial results from GGS-II in Croatia? Click [here](#) to catch up on this GGP-connect webinar.

Harmonised Histories Czech Republic: Out now!



Thanks to the efforts of **Almut Schumann** (German Federal Institute of Population Research) a new file has been added to the Harmonized Histories dataset: **Czech Republic**. The new Harmonized Histories dataset is based on the GGS data collection in Czech Republic from November 2020 until July 2022. This dataset has a sample size of 5,583 (3,296 women and 2,287 men).

The Harmonized Histories dataset is an international comparative dataset that focuses on fertility and partnership histories. It also captures information on socioeconomic status, place of residence, childhood family, and other relevant demographics. The fertility and partnership biographies are available in a **standardized and user-friendly data format**. By now this dataset covers a wide range of 26 countries around the globe and captures information of over 390,000 individuals in total.

Updates from the GGP Central Hub



Fieldwork for GGS Netherlands (CAWI, age 18-59) is drawing to an end. Three reminder letters have been sent and over 6,300 interviews have been completed so far (RR= 23,7%). The second phase of fieldwork started in April. Its response is lower than expected based on the results of the first (experimental) phase. Seasonal effects might have played a role. The Dutch national team might send out a fourth reminder in September to boost the response. After their pilot, the national team in **Taiwan** has started preparations for a full GGS-II wave 1 (CAWI + CAPI). Fieldwork is scheduled to start in November 2023.

Koops has received this price for her research proposal focused on the question: **To what extent does an unplanned pregnancy affect the economic position of women after the birth of the child?**

The award grants laureates a three-year appointment as a postdoctoral researcher at one of the KNAW's research institutes. The GGP's Central Hub team is looking forward to welcome Judith back **at the Netherlands Interdisciplinary Demographic Institute (KNAW-NIDI)** to pursue her research project using GGS data.
