Ciao a tutti! GGP at ESRA in Milan



This July, GGP Central Hub members Wojciech Jablonski, Almut Schumann, Olga Grunwald and Arianna Caporali attended **the European Survey Research Association** (<u>ESRA</u>) **2023 Conference** in Milan, Italy.

Organized biannually, the ESRA conference is the most prominent and significant scientific event in the field of survey methodology in Europe. The GGP team contributed to the program by giving six presentations on recent methodological work. We presented on the transition from a <u>face-to-face to</u> <u>mixed-mode</u> approach in the GGS, the use of <u>mobile devices</u> while completing interviews and <u>data documentation</u> and <u>harmonization</u> issues in the new round of the GGS. We also gave presentations on providing <u>panel consent</u>, as well as our experiences in fielding the <u>GGS in Latin America</u>.

Harmonised Histories Italy: Out now!



Thanks to the efforts of Almut Schumann (German Federal Institute of Population Research) a new file has been added to the Harmonized Histories dataset: **Italy**. The new Harmonized Histories dataset is **based on the 'Families, social subjects and life cycle' (Fss) survey in Italy fielded in the summer of 2016**. This dataset has a sample size of 24,753 (12,714 women and 12,039 men).

The Harmonized Histories dataset is an international comparative dataset that focuses on fertility and partnership histories. It also captures information on socioeconomic status, place of residence, childhood family, and other relevant demographics. The fertility and partnership biographies are available in a **standardized and user-friendly data format**. By now this dataset covers a wide range of 26 countries around the globe and captures information of over 415,000 individuals in total.

Fieldwork update



Early July, fieldwork was completed in **Croatia** (CAWI). In total, more than 7000 interviews were collected. This constitutes a response rate of 28%.

The Dutch national team decided to extend fieldwork for GGS **The Netherlands** (CAWI, age 18-59), because the response is lower than expected. So far, about 6,500 respondents have completed the questionnaire (24,2%). An additional fourth and final reminder will be sent out this September. The survey is now scheduled to close in October.

Fancy a trip abroad? Apply for a Transnational Access Visit!



The fourth call for the COORDINATE Transnational Access Visits is open for applications. The call is aimed at researchers and policy practitioners in the area related or adjacent to **children and/or youth wellbeing as well as methodological aspects of cohort and longitudinal studies.** The programme enables participants to to visit a research infrastructure and access the most relevant European birth cohort, panel and cross-sectional survey data. Accepted applicants will have the opportunity to spend from **one to three working weeks** at one of the eight partner institutions, gain access to data, conduct their own research, benefit from the support of local experts, and expand their skills. **Previous calls have shown that close to 75% of applications are successful.** Applicants' travel costs, accommodation, and subsistence will be reimbursed as specified in the call.

GGP community members are especially encouraged to apply with projects using GGS data to visit the GGP CCT at NIDI in the Hague.
