INED visits the GGP in the Hague



In February, the GGP hosted a collaborative **two-day workshop with our colleagues from INED**. The workshop focused on operational aspects of the GGS-II, specifically addressing **fieldwork methodologies** and **post-fieldwork procedures** in preparation for the upcoming GGS-II Wave 2.

The sessions included discussions on optimizing workflow integration, structural considerations for GGS-II Wave 2 and insights from country-led data collection and how to harmonise these initiatives with GGS standards. Funding secured for GGS-II Poland



We are pleased to announce that the Polish Generations and Gender Programme (GGP-PL) at the **Warsaw School of Economics** has successfully **secured funding for the new round of GGS-II** under the project "GGP-PL: Generations and Families. Panel study on changing relations between generations, within the family, and between women and men."

This funding, provided by the Polish Ministry of Science program "Support for the Participation of Polish Scientific Teams in International Research Infrastructure Projects," will support the activities of the GGP-PL, led by **Monika Mynarska**, for the next five years. The grant will facilitate **two full waves** of GGS-II and an in-between local survey, with anticipated data collection scheduled to commence by the end of 2024. Furthermore, the funding will support activities aimed at disseminating the data and fostering its broader accessibility and utilization within the research community and beyond.

Call for applications for Transnational Access Visits



The fifth call for the COORDINATE Transnational Access Visits is open for applications. The call is aimed at researchers and policy practitioners in the area related or adjacent to children and/or youth wellbeing as well as

methodological aspects of cohort and longitudinal studies. The programme enables participants to visit a research infrastructure and access the most relevant European birth cohort, panel and cross-sectional survey data. Accepted applicants will have the opportunity to spend from **one to three working weeks** at one of the eight partner institutions, gain access to data, conduct their own research, benefit from the support of local experts, and expand their skills. **Previous calls have shown that close to 75% of applications are successful.** Applicants' travel costs, accommodation, and subsistence will be reimbursed as specified in the call.

GGP community members are especially encouraged to apply with projects using GGS data to visit the GGP CCT at NIDI in the Hague.

Updates from the GGP Central Hub



Fieldwork progress in **Taiwan** is on track, with over 4,000 completed CAWI interviews and a response rate of approximately 10%. In April, Taiwan will transition to the CAPI mode for data collection. Meanwhile, **Italy** and **Poland** are in preparation for the **baseline wave** (GGS-II Wave 1).

As for the **follow-up wave**, **Norway** is set to commence fieldwork in April, exclusively using CAWI as the data collection mode. **Moldova** and **Estonia** are also preparing for their follow-up wave fieldwork and will start data collection shortly.
