GGP at the CSDI Workshop 2025



The GGP was prominently featured at the **2025 International Workshop on Comparative Survey Design and Implementation (CSDI)**, hosted this year by Sample Solutions in Skopje, North Macedonia. The workshop brought together leading experts from around the world to explore **innovations and challenges in survey methodology**, with a strong focus on improving quality, comparability, and implementation in cross-national surveys.

Representing the GGP Central Coordination Team, **Ilaria Francesca Lunardelli**, **Aisling Connolly**, and **Julia Rokos** delivered a series of presentations showcasing ongoing research and developments from the GGS-II on:

• Unmet Family Planning Needs in the GGS-II

- Exploring Educational Bias in the GGS-II
- Enhancing Cross-National Comparability in the GGS-II

Throughout the two-day programme, the workshop sessions addressed a wide range of methodological issues, including **questionnaire testing, sampling innovations, translation quality, and the application of emerging technologies in survey research.** The GGP team's contributions sparked meaningful discussion and shared valuable insights into the challenges and solutions involved in conducting high-quality, comparative demographic research.

GGP Featured on the Icelandic Research Infrastructure Roadmap!

CRONOS-3 Data Release



The first two waves of data from the **CROss-National Online Survey 3** (CRONOS-3), a core component of the **Infra4NextGen** project, are now publicly available via the **European Social Survey (ESS) Data Portal**.

The GGP has played an active role in this collaborative initiative, which brings

together leading European research infrastructures to generate high-quality, policy-relevant data in support of the **NextGenerationEU** recovery plan.

CRONOS-3 was conducted across eleven countries in late 2024, using a mixedmode approach, and captures public attitudes across five key policy domains central to Europe's recovery: **digital transformation**, **equality**, **sustainability**, **health**, **and social resilience**.

GGP-Connect Insights and Impact Webinar: Germany



The most recent GGP-Connect Insight and Impact webinar took place on the 29th of April at 13:00 (CET). In this session, **Martin Bujard f**rom the Federal Institute for Population Research (BiB) presented "**GGS Data Every Year?!** Insights from Three Waves of Germanys' FReDA on Well-being and Fertility Intentions."

The talk provided an overview of the development of the German GGS-II within the framework of the FReDA panel study, which was launched in 2021. The GGS-II German team outlined the panel design, sample attrition, and the integration of related modules such as FReDA-pairfam and FReDA-Ukraine. The presentation highlighted key findings on changes **in subjective well-being during a time of overlapping crises**, and **how fertility intentions evolved between April 2021 and January 2023.** The team also emphasized the importance of continued monitoring, paying attention to vulnerable groups, and implementing supportive policy measures.

Updates from the GGP Central Hub



Fieldwork

Wave 1 (Baseline): Funding has been secured for GGS-II Switzerland, coordinated by the University of Lausanne and FORS, with fieldwork planned for 2026. Preparations are also underway in Iceland, Italy, Hungary, Latvia, Lithuania, Poland, and South Korea. Italy will enter the field in May.

Wave 2 (Follow-up): Czechia is in the field with over 1,900 interviews

completed in CAWI. Estonia began in March and has already conducted more than 5,320 interviews in CAWI.

Data Processing

France and Taiwan (Wave 1) are currently being processed, with France due for release soon. Moldova's Wave 2 data is being finalised, with a launch event set for September.
