Structure of the printed questionnaire:

A Introductory questions

B Blocs of questions to be answered either on laptop or on-line

This part of the questionnaire may be filled in either on laptop and on-line. The wording of the questions in this printed version corresponds to the laptop-based questions. (Response cards, etc.) The contents of the on-line version is essentially the same, with some typographic differences.

The on-line questionnaire starts with the (slightly modified) introductory questions of Block A.

C Household structure and the division of labour in the family

To be filled in only on laptop.

D Questions to be filled in only on laptop

Other remarks:

The answer options **doesn't know (DK)** and **doesn't wish to answer (NA)** can be entered in the data entry software in three ways, depending on the form of the question.

1 For the majority of the questions, these options are offered but can be entered with the use of special key combinations. In the case of routing questions, the * sign indicates the option with which the programme proceeds in case of a DK or NA code.

Example:

Do you also earn money from an additional job or business?

```
1 – yes
2 – no * → GO TO 321!
```

In this case, if the respondent does not know or does not wish to answer, they go to question 321.

- 2 In some particularly sensitive cases (e.g. income, denomination), the DK and NA options are explicitly offered in the questionnaire.
- 3 However, there are a few mandatory questions, indicated by the § sign. In these cases, the data entry software gives an error message if DK or NA codes are entered, so these codes are not allowed.

Example:

4 The corresponding variable names are printed in the questionnaire next to each question. In Block B two variables are provided for some questions. In these cases, there is some discrepancy between the question wording or the answer options between the laptop and the on-line versions.

Example:

Variable names: laptop version - k4hazno; on-line version - k4hazno_a

(In the laptop version, respondents could choose any value over the age of 16, while the online version included an 'over 40 years' aggregated category.)

5 For questions where the answers are to be entered in a table, the variable names associated with the question appear in the table (e.g. the household grid in Block C).
